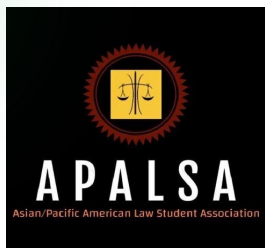

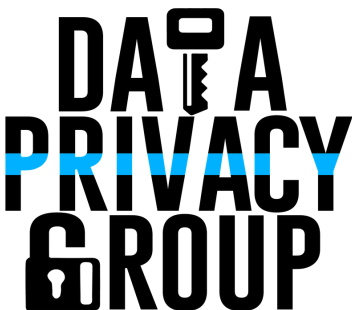
The Coalition Advocating Transportation Solutions

DATA PRIVACY GROUP (DPG)

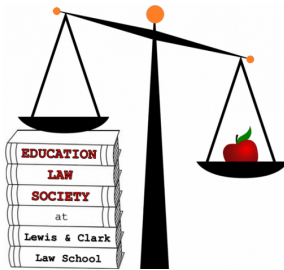
