Who We Are

The National Crime Victim Law Institute (NCVLI) is a 501(c)(3) nonprofit legal education and advocacy organization located at Lewis & Clark Law School in Portland, Oregon. For 21 years, we have actively promoted victims' rights and victims' voices in the justice system through crime victim centered legal advocacy, education and public policy. NCVLI hosts the only national Conference focused on rights enforcement in victim law.



LEGAL ADVOCACY

We pair crime victims with no cost attorneys who fight to secure their rights. We ensure that every attorney and advocate can make the best arguments for the victims they serve by providing them with legal technical assistance. We file amicus curiae briefs explaining the national implications of cases to courts and suggest how their decision will impact future victims.



PUBLIC POLICY

We work with partners nationwide to secure the next wave of victims' rights legislation that guarantees victims have substantive rights and the procedural mechanisms to secure those rights. We provide model legislation and testify when called upon.



EDUCATION

We train nationwide on the meaning, scope, and enforceability of victims' rights through practical skills courses, online webinars, teleconferences and our national Conference.

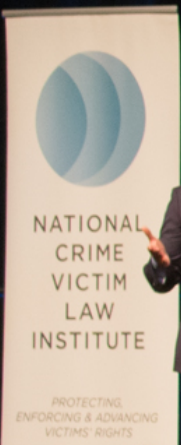
About the Conference

The Crime Victim Law Conference brings together leading attorneys, advocates, judges, military personnel, mental health professionals, law enforcement, program managers, academics, students and survivors in the victims' rights field. 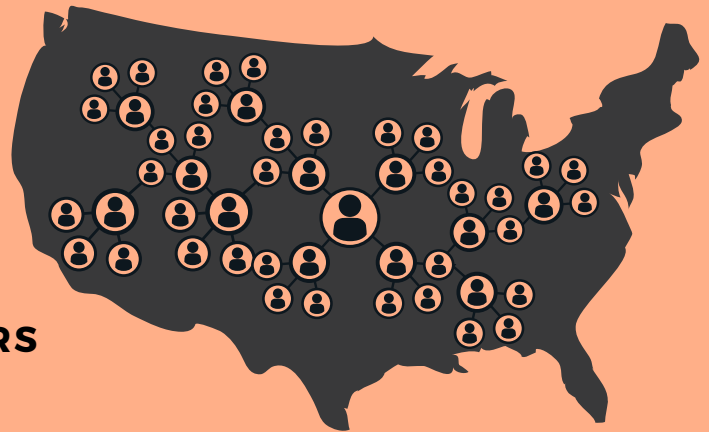

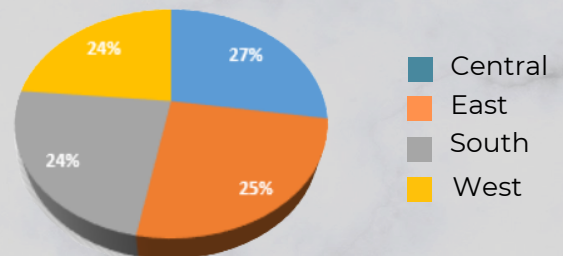

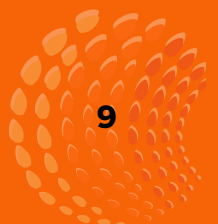
