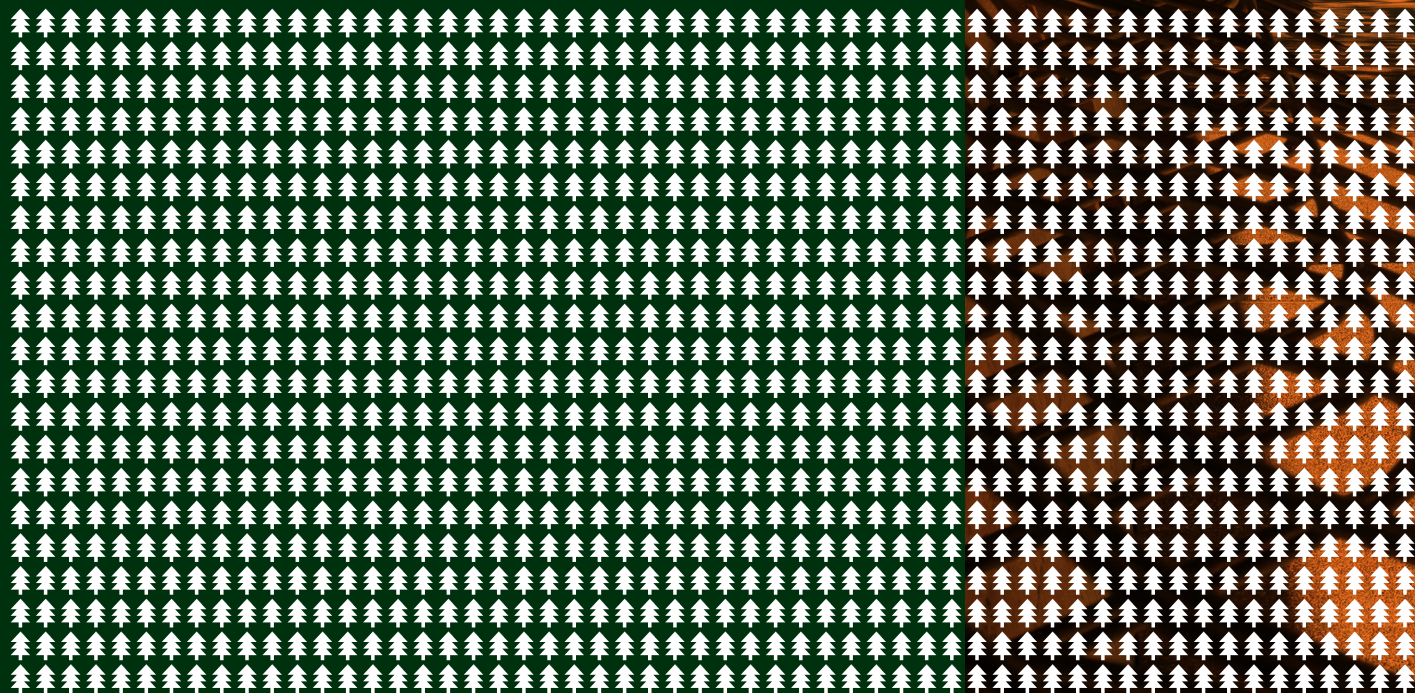

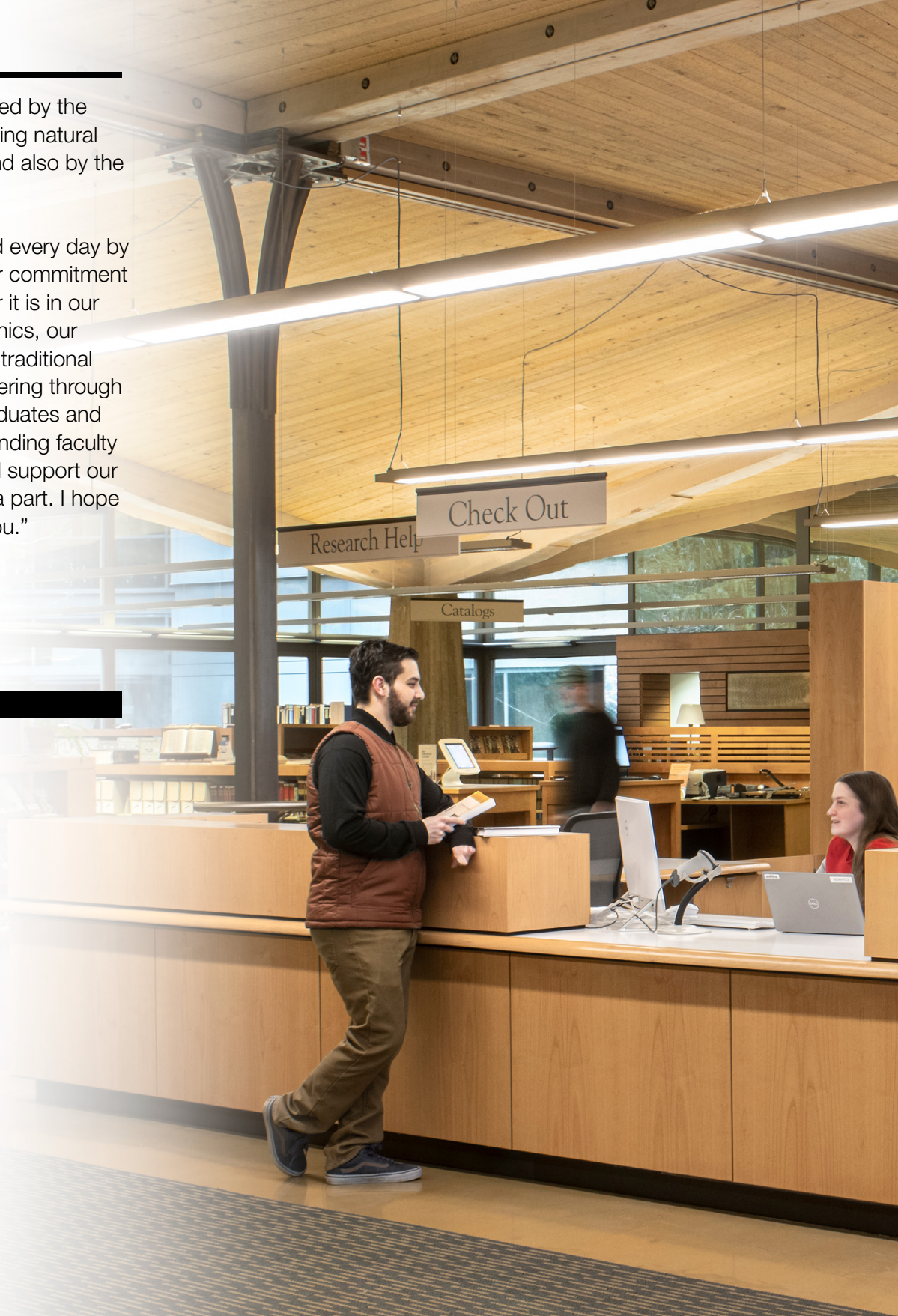

# MENTORING MEANS SUCCESS

From the first time you set foot on campus, until long after graduation, you will have access to a strong system of academic and professional support. Through our comprehensive Mentor Network, all incoming students are paired with not one but four mentors:

**Peer mentors** share study skills, exam strategies, and help navigate the ins and outs of first year law school life. They also share tips on the best local spots for coffee, food, studying, and more.

**Faculty advisors** are there to provide perspective and assistance in class choices, paper topics, and career advice.

**Career Services advisors** assist with professional development and job search strategies, both during your legal education and beyond.

**Attorney mentors**, often alumni, offer invaluable insights and connections within the legal community.

## OUTCOMES THAT SPEAK FOR THEMSELVES

Our results speak for themselves. Over 90% of the class of 2023 secured employment within ten months of graduation, with nearly 85% in positions requiring or preferring a JD degree.

For the second year in a row, L&C had the highest bar pass rate in the state of Oregon, with 83 percent of our first-time bar takers passing. Additionally, our faculty have championed the implementation of Oregon's Supervised Practice Portfolio Examination (SPPE) which offers our graduates an alternative path to licensure in Oregon. No matter the method, our students find success in their future because of the education they receive at Lewis & Clark.
